All legal documents must be presented as originals and attested by a UAE court or Embassy - RAK FTZ has the right to ask for extra attestation where necessary. Legal documents must be either in Arabic or English - documents in any other languages must be accompanied by a certified English or Arabic translation.

Company registration is applicable for new establishments not branches. For branches, the Parent Company should have existed for more than one year (also applicable to Subsidiary Company). All new entity applicants should open a bank account within 90 days of the Certificate of Incorporation to avoid paying a penalty to revalidate the Certificate of Incorporation. Minimum account balance for General Trading License is AED 500,000.
